PURPOSE

- To promote environmental sustainability at the school level including areas such as waste, energy, water, and biodiversity.
- To reduce the amount of waste produced so that the minimum amount is sent to landfill.
- To include waste-reduction strategies as part of the whole school program involving students, parents, teachers, and the wider community.
- To increase awareness of the importance of conservation of resources such as water and energy.
- To engage students in authentic, hands-on learning opportunities centred around sustainability including gardening, water conservation and biodiversity.

SCHOOL COMMUNITY BENEFITS

- Development of a more attractive and healthier school environment
- Financial savings due to reduced waste removal (Cleanaway)
- Students learn environmentally sound attitudes and habits

DEFINITIONS

Sustainability addresses the ongoing capacity of Earth to maintain all life.

GUIDELINES

- The coordinator will lead a student-centred committee for sustainability that will meet during lunch times about once a week.
- The committee will circulate relevant information to the staff/school community through staff meetings, newsletters, etc.
- Reduce, re-use, re-cycle and re-purpose strategies will be incorporated into the school's everyday activities.
- Sustainability initiatives will be driven by the student body boosting student voice and agency.

IMPLEMENTATION

- The following whole-school programs will operate:
 - o paper and cardboard will be re-cycled through Cleanaway, or a similar service
 - o recyclable containers will be recycled through curbside collection each fortnight
 - o Organic/compostable waste will be recycled through our composting system
- The re-cycling collection system will be visible, convenient, safe, secure and have clear instructions.
- The school will participate in environment focused activities each year as decided by the staff. These could include activities such as 'rubbish free lunch days' and 'walk to school days'.
- Sustainability strategies for conservation, care of resources and the topics of sustainability, will be incorporated into the relevant areas of the classroom teaching and learning program in line with the <u>Victorian Curriculum Cross-Curricular Priority Learning about Sustainability</u>.
- New environmental sustainability programs will be developed on a need's basis.
